I agree to save harmless indemnify and keep indemnified Gliding New Zealand, the Omarama Gliding Club, the Sailplane Racing Committee and their respective officers, members, employees, agents, and representatives (the "organisers") against all actions, suits, claims and demands costs, damages and expenses to which the organisers shall or may be liable for or in respect of any loss, damage, accidents or injury of whatsoever nature or kind and howsoever sustained or occasioned and whether to aircraft property or persons arising directly or indirectly or in connection with this gliding championship or activity related thereto and notwithstanding that any waiver or other indulgence has been given to any pilot(s) in respect of any obligation and I shall and do hereby fully and completely indemnify and protect the organisers against all or any liability for damage loss or injury caused by any act, omission or negligence on the part of me and my servants, agents or crew.

- (b) I am legally qualified to fly in New Zealand during the period of the competition; and
- (c) The parachute in use has been re packed within the past 12 months
