I further declare that:

- a. The entered aircraft is legal to fly in New Zealand during the period of the contest
- b. The pilot is legally qualified to fly in New Zealand during the period of the contest
- c. The pilot and aircraft are covered by current third party insurance cover from _____ (company) to the value of at least \$500,000.
