Background - Gliding New Zealand Umbrella Trust

The Trust was established on 10 June 2012 in order to become the vehicle by which all the various gliding trusts that exist throughout NZ could consolidate their investments into one trust. Consolidating the individual capital sums from the various trusts into a worthwhile amount has maximised investment returns, and allowed more professional management of the trusts' funds, giving better accountability. The objectives of the Trust are to

- provide support to the sport of gliding within New Zealand
- provide support to New Zealand glider pilots participating in international competitions
- establish and administer separate named funds within the Trust Fund to fulfil the wishes of individual donors who wish to support the sport of gliding within New Zealand
